No. F 1-2/56/2013/IT BT/454: Whereas under Government Notification No.1-2/56/2013/IT BT/ 452 dated 27 September, 2013 issued under sub-section (1) of Section 70 of the Information Technology Act (no. 21 of 2000) (hereinafter referred to as "the said Act"), the Government of Chhattisgarh has declared the computers, computer systems, computer networks, computer resources and communication devices which directly or indirectly affects the facility of Critical Information Infrastructure mentioned in the Schedule appended hereto, to be a protected system;

And whereas it is necessary to authorise certain persons under sub-section (2) of section 70 of the said Act to access protected systems notified under the said Notification;

Therefore in exercise of the powers conferred by sub-section (2) of Section 70 of the said Act, the Government of Chhattisgarh hereby authorises the persons mentioned in column (3) of the Table below to access the protected systems respectively mentioned against the said persons in column (2) thereof.


