- Rural Development Projects, Supporting Projects and Voluntary Organizations.
- Parliament, Parliamentarians, Legislative Assemblies, Member of Legislative Assembly.
- Women and Child Welfare Programmes.
- Exporters, Export Promotion and Export-Support Organizations
- Public Service Examinations.
- Water Management and Irrigation Information Systems.
- Sustainable Development Projects and Programmes for people below poverty line.
- Welfare of SC/ST and other Weaker Sections.
- Backward Area Development.
- Steel, Coal, Power, Cement and Transport Sectors.
- Marketing of Government Databases.
- Tourism Industry
